**INTRODUCTION OF A BILLING SYSTEM FOR LOADING AND
OFFLOADING OF CRUDE OIL AT OFFSHORE OIL AND GAS
INSTALLATIONS**

The Government of Ghana acting through the Ministry of Transport and the Ghana Maritime Authority and in collaboration with Messrs. Kusart Maritime Services Limited would from 26th October, 2022, commence the implementation of a Billing System for Loading and Offloading of Crude Oil at Floating Production, Storage and Offloading (FPSO) installations within Ghana's territorial waters.

This is in line with the provisions of the Fees and Charges (Miscellaneous Provisions) Act, 2022 (Act 1080) which provides for the imposition of terminal and berth occupancy charges on vessel accessing Floating, Production, Storage and Offloading (FPSOs) installations to load or offload crude. The Billing System is applicable to all vessels providing services at the FPSO Kwame Nkrumah, the FPSO Atta Mills and the FPSO John Kufuor. The applicable charges are as follows:

- 1) Terminal Charges - USD\$ 2.69 per Metric Tonne
- 2) Berth Occupancy Charges - US\$2.41 for the 1st 24-hours of berthing

A Billing System has been developed to facilitate and automate the processes of invoicing and collection of payments, invoice tracking and reconciliations. The Billing platform can be assessed at <https://services.bollos.net/bolos-app/>.

Vessels intending to access the FPSO's would be required to complete a Request via the BOLLOS- Billing Offloading and Onloading System Portal and pay the applicable charges before entry.

By a copy of this letter, all Ship Owners and Agents as well as Charterers are requested to take note and act accordingly.
